**NOTICE TO PERSON ENTERING CHALLENGE:** In accordance with F.S. 101.111(2), any elector or poll watcher filing a frivolous challenge of any person's right to vote commits a misdemeanor of the first degree, punishable as provided in s. 775.082 or s. 775.083; however, electors or poll watchers shall not be subject to liability for any action taken in good faith and in furtherance of any activity or duty permitted of such electors or poll watchers by law. Each instance where any elector or poll watcher files a frivolous challenge of any person's right to vote constitutes a separate offense. Copies of this completed form will be provided to the voter who has been challenged as well as the election board of the challenged voter's precinct.

**NOTICE TO VOTER WHO HAS BEEN CHALLENGED:** In accordance with the provisions of F.S. 101.111, your right to vote in this election has been challenged by the individual listed above. If the basis for the challenge is that your legal residence is not in the precinct noted above, you shall first be given the opportunity to execute a change of legal residence in order to execute a regular ballot. Otherwise, you are entitled to cast only a Provisional Ballot in this election.

**NOTICE TO ELECTION BOARD AT PRECINCT OR EARLY VOTING SITE:**

1. Hand the copy of this completed form to the voter who has been challenged and point out the NOTICE TO VOTER WHO HAS BEEN CHALLENGED above.
2. In accordance with the provisions of F.S. 101.111, if the basis for this challenge is that the person's legal residence address on record is incorrect, the person shall first be given the opportunity to execute a change of address in order to be eligible to vote a regular ballot. **FOR ELECTION DAY VOTING:** If the new address places the voter in this precinct, the voter is entitled to cast a regular ballot. If the new address places the voter in another precinct, the voter may be transferred to that precinct to cast a regular ballot. If the voter refuses the transfer and insists they reside in this precinct, they are entitled to cast a Provisional Ballot.
3. Once completed, attach the white copy of this form to either the Voter Update Form or Provisional Ballot Certificate Envelope.
